

YG Network: National Survey Results

Methodology:

This national survey of 1,000 likely 2014 general election voters was conducted from March 4th to March 7th, 2013.

Interview selection was random within predetermined election units. 700 interviews were conducted via landline telephone by professional interviewers. To increase coverage, this landline sample was supplemented with 300 interviews of cell-phone only users reached via the internet. These samples were then combined and structured to correlate with actual voter turnout in a nationwide general election.

This poll of 1,000 likely general election voters has an accuracy of +/- 3.1% at a 95% confidence interval.

Major Findings:

1. **By strong margins, respondents are most concerned with economic issues and in turn believe that they will have the greatest impact on their future.**
 - Three in four respondents (76%) believe America stands at an economic crossroads that require us to make tough choices today to avert a crisis, while only 18% say we are generally on the right path.
 - When given a list of choices, 90% say an economic related issue would have the most impact on their future, with “economy and jobs” (38%), “deficit and debt” (20%) and “healthcare” (16%) being the highest economic issues. It is important to note that “economy and jobs” is almost twice that of “deficit and debt.” Just 7% of respondents see social issues as having the most impact.
 - While economic related issues (82%) are still seen as having the most impact when asked for a second choice, “healthcare” is the single highest economic issue at 24%.
 - Out of issues tested that are currently facing the country, respondents are most concerned with “energy prices” (85%), “government spending” (83%) and “taxes” (82%). It is important to note that intensity of concern is higher for “government spending” than “taxes” and “energy prices” – 49% “very concerned,” 39% “very concerned” to 38% “very concerned,” respectively.
 - Energy prices, including gas, an important pocketbook issue, are hurting personal finances more than the national debt or government regulations – 88%, 71% to 61%, respectively.
 - When respondents were presented with the largest items in the federal budget to cut, welfare programs far outweighed military, Social Security and Medicare.
 - Four in ten (42%) are concerned that either they or someone in their household might be out of work in the next 12 months, while 54% are not concerned.

Major Findings:

2. Issue Analysis – Healthcare

A. Pluralities of respondents believe that the Affordable Healthcare Act of 2010 will increase healthcare costs and make things worse.

- Forty-four percent (44%) say the Affordable Healthcare Act will make things worse, including 29% who say it will make things “a lot worse.” Three in ten (28%) say it will make things better and 21% say it will have no effect.
- When it comes to premiums, co-pays and deductibles, 45% say the Affordable Healthcare Act will make them more expensive, 27% say they will remain the same and only 9% say they will be less expensive as a result.
- A majority (53%) say those opposed to the Affordable Healthcare Act should either work to repeal all of it (32%) or change it as much as possible (21%). Thirty-five percent (35%) say those opposed should stop trying to block the law’s implementation.
- Regarding the changes the Affordable Healthcare Act made to the healthcare system, 61% disapprove of the insurance premium tax and nearly half (47%) disapprove of IPAB. Respondents are more divided on the essential health benefits package (42% approve to 44% disapprove).

Major Findings:

2. Issue Analysis – Healthcare (Cont.)

B. When it comes to Medicare, respondents favor means testing and gradually raising the age of eligibility.

- After being informed that Medicare is on an unsustainable path to insolvency, 65% favor reducing benefits for seniors with higher incomes and 53% favor gradually raising the eligibility age from 65 to 67 for future retirees.
- Respondents are more divided when it comes to introducing immediate changes to Medicare, even if it meant balancing the budget within ten years (47% favor to 43% oppose).
- Nearly six in ten (56%) believe that Medicare eligible seniors should be allowed to use government subsidies to stay on their private health plans instead of automatically enrolling in Medicare.

Major Findings:

3. Issue Analysis – Immigration Reform

- Almost seven in ten (67%) believe that the United States could be doing more when it comes to keeping illegal immigrants from crossing into the United States, while only 24% believe the government is doing all it can be reasonably expected to do.
- When it comes to illegal immigrants who are currently working in the United States, half (48%) believe they should be allowed to stay in their jobs and to eventually apply for citizenship and another 19% favor a guest worker policy. One in four (26%) believe they should no longer be permitted to live and work in the United States.
- Three in four (75%) favor providing a pathway to citizenship for illegal immigrants under the age of 30 who were brought to the United States as children as long as they do not have a criminal record and obtain either two years of college or military service, while only 20% oppose. Intensity, though, is soft on the positive side, as only 42% “strongly favor” this approach.

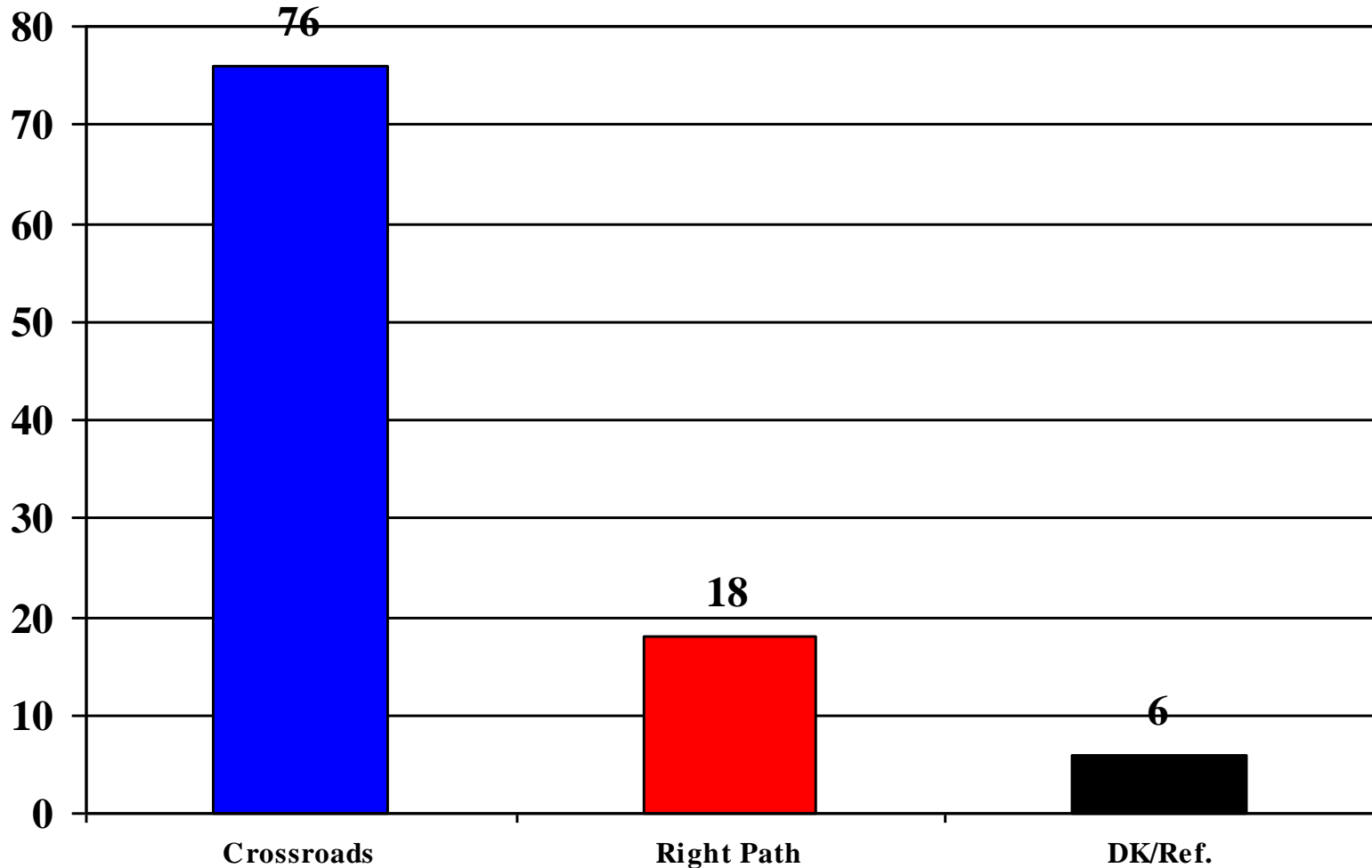
Major Findings:

4. **Greater than eight in ten (84%) agree that it is possible for the United States to focus on energy production and environmental production at the same time.**

5. **Issue Analysis – Education**
 - Nearly nine in ten (88%) favor providing parents a full breakdown of college tuition costs, including 66% who “strongly favor.”
 - Another 85% favor providing prospective college students with reliable information such as employment rate and potential earnings.

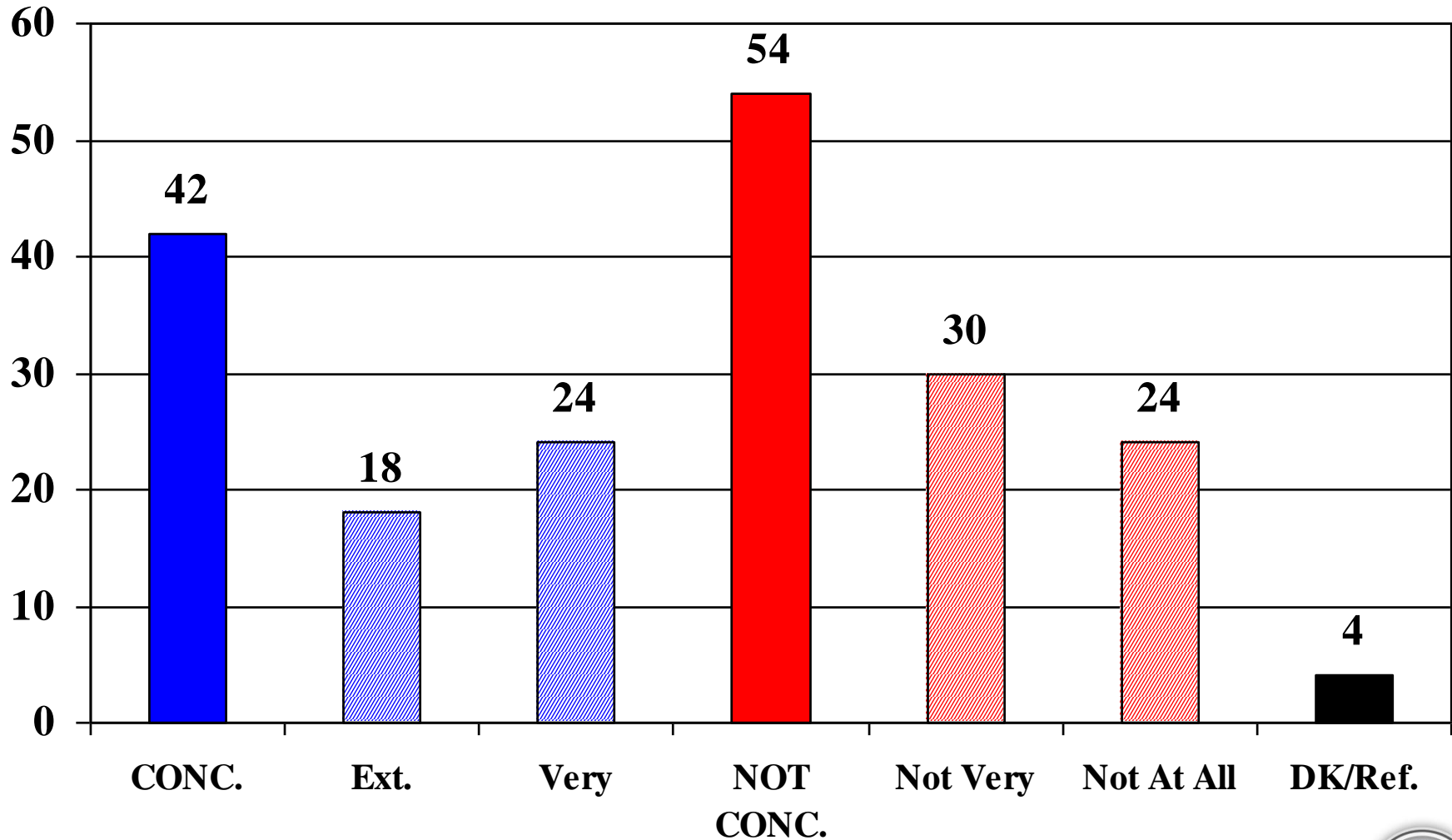

How concerned are you in the next 12 months that you or someone else in your household might be out of work and looking for a job?

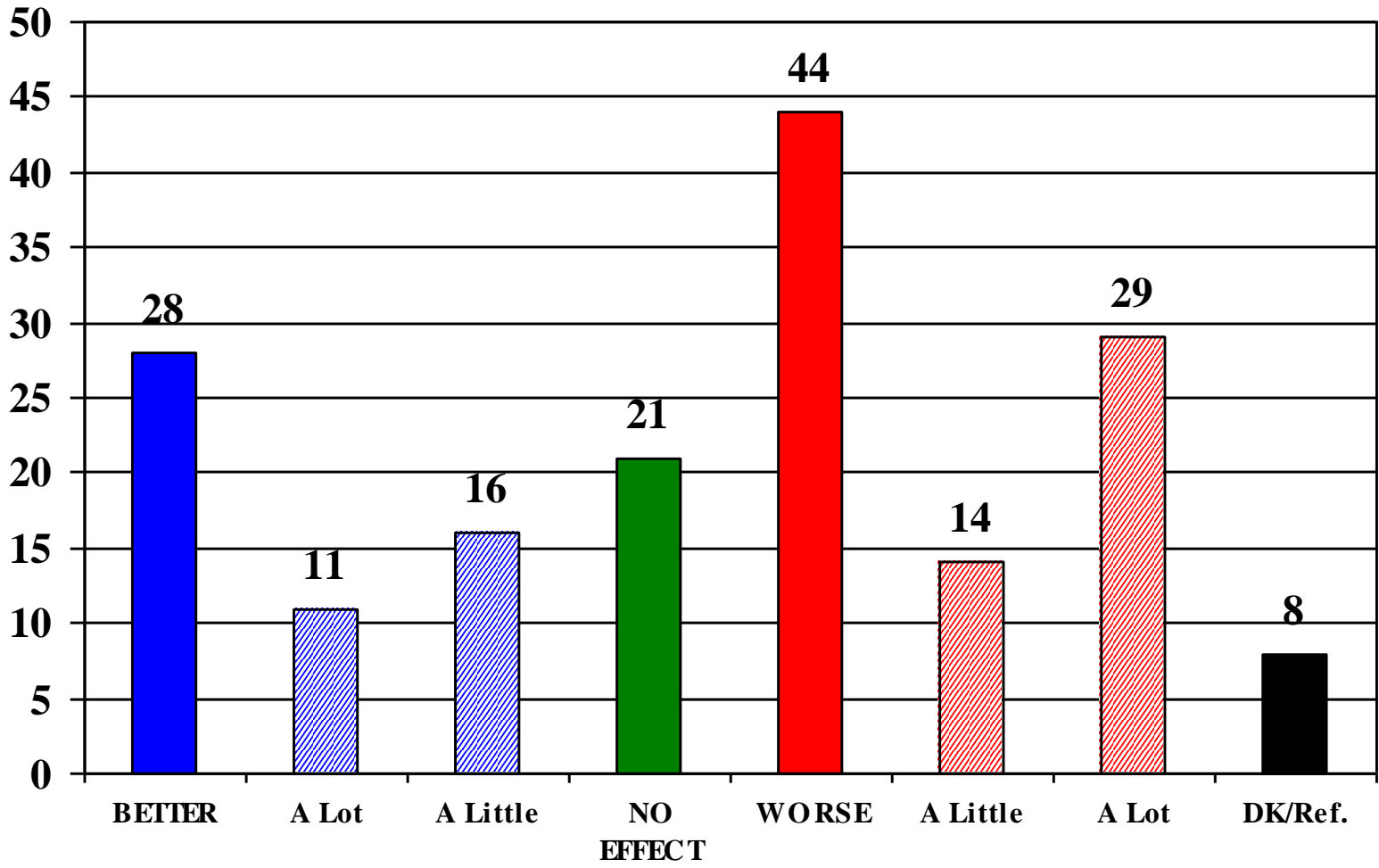

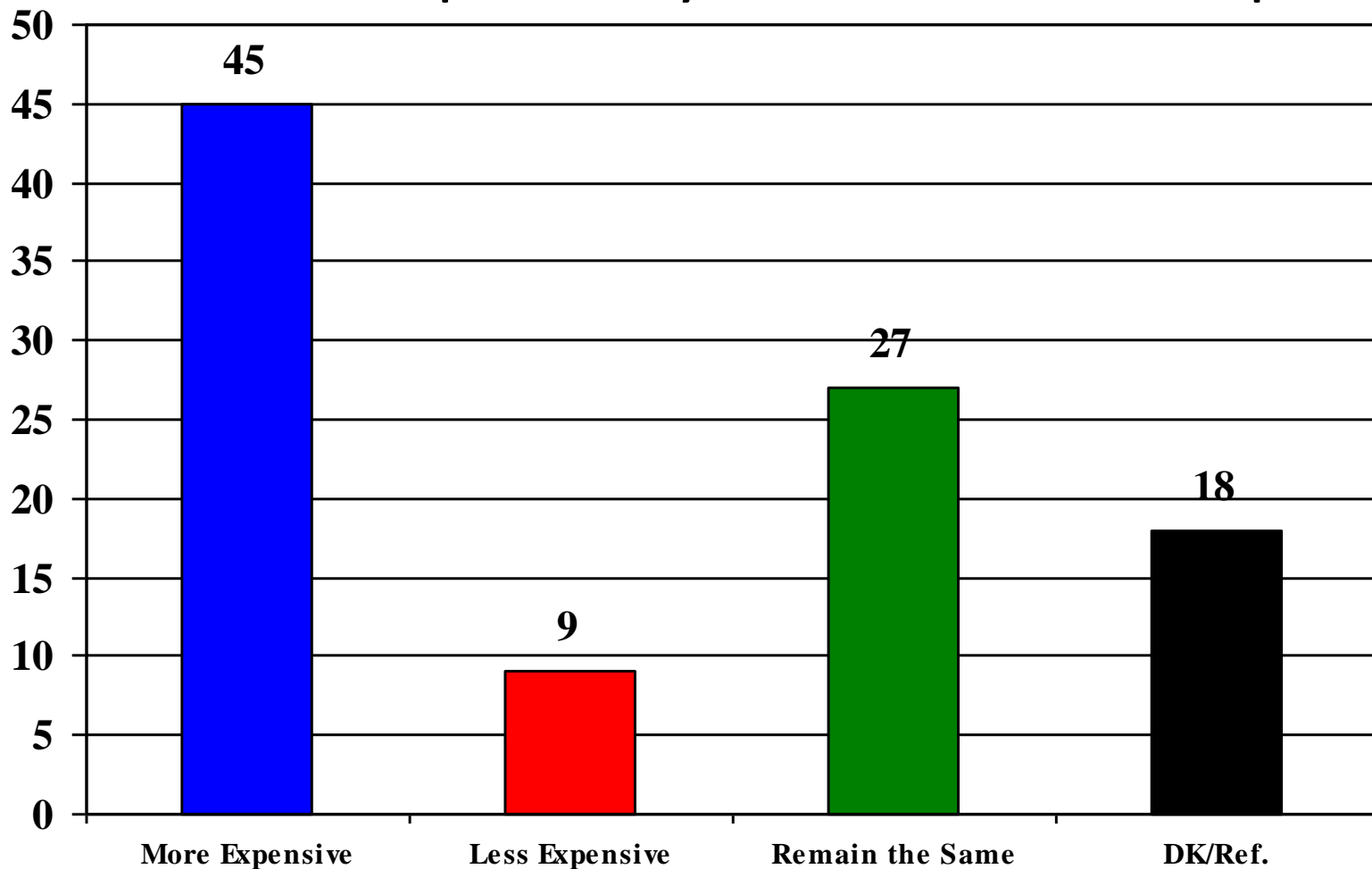

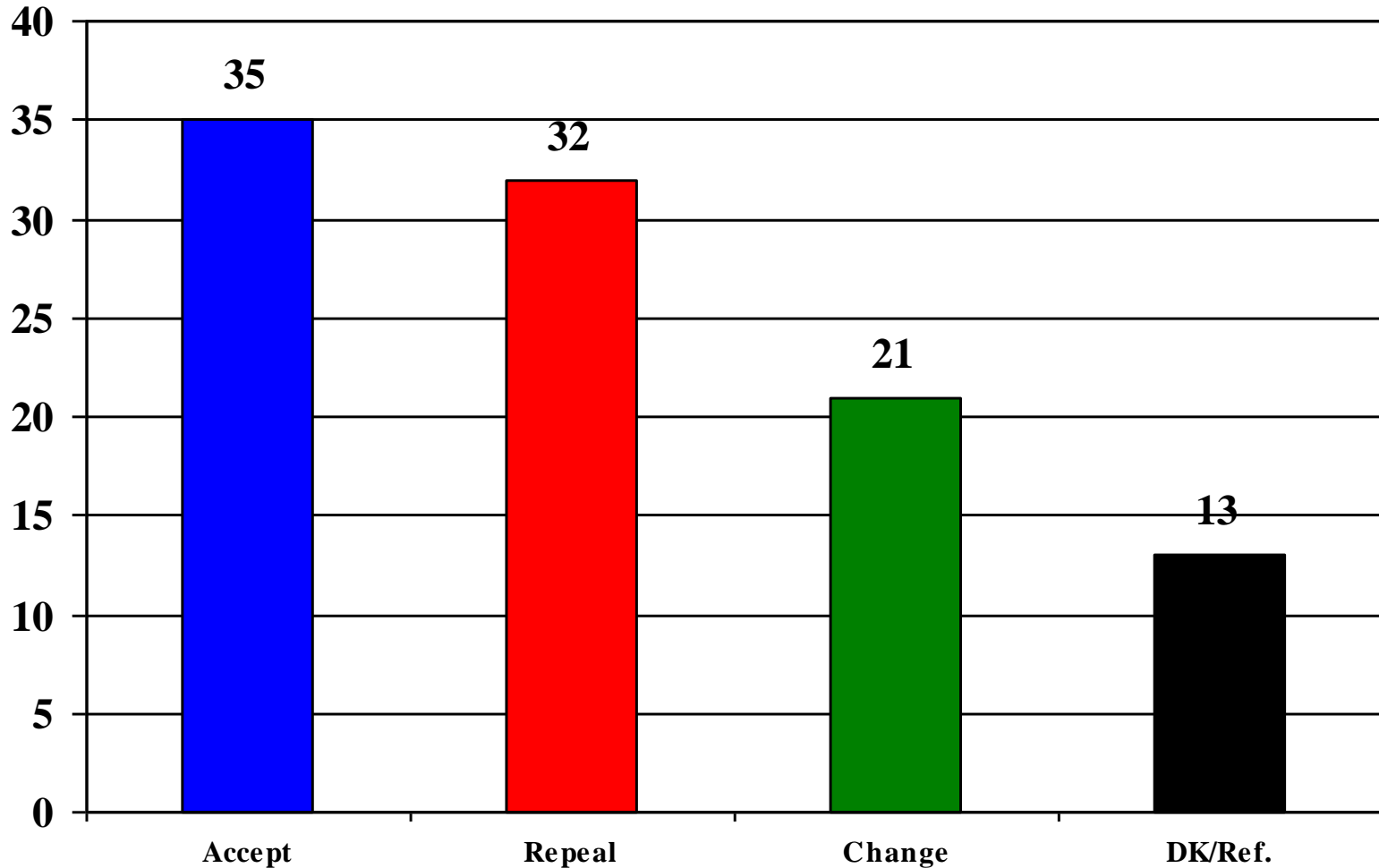

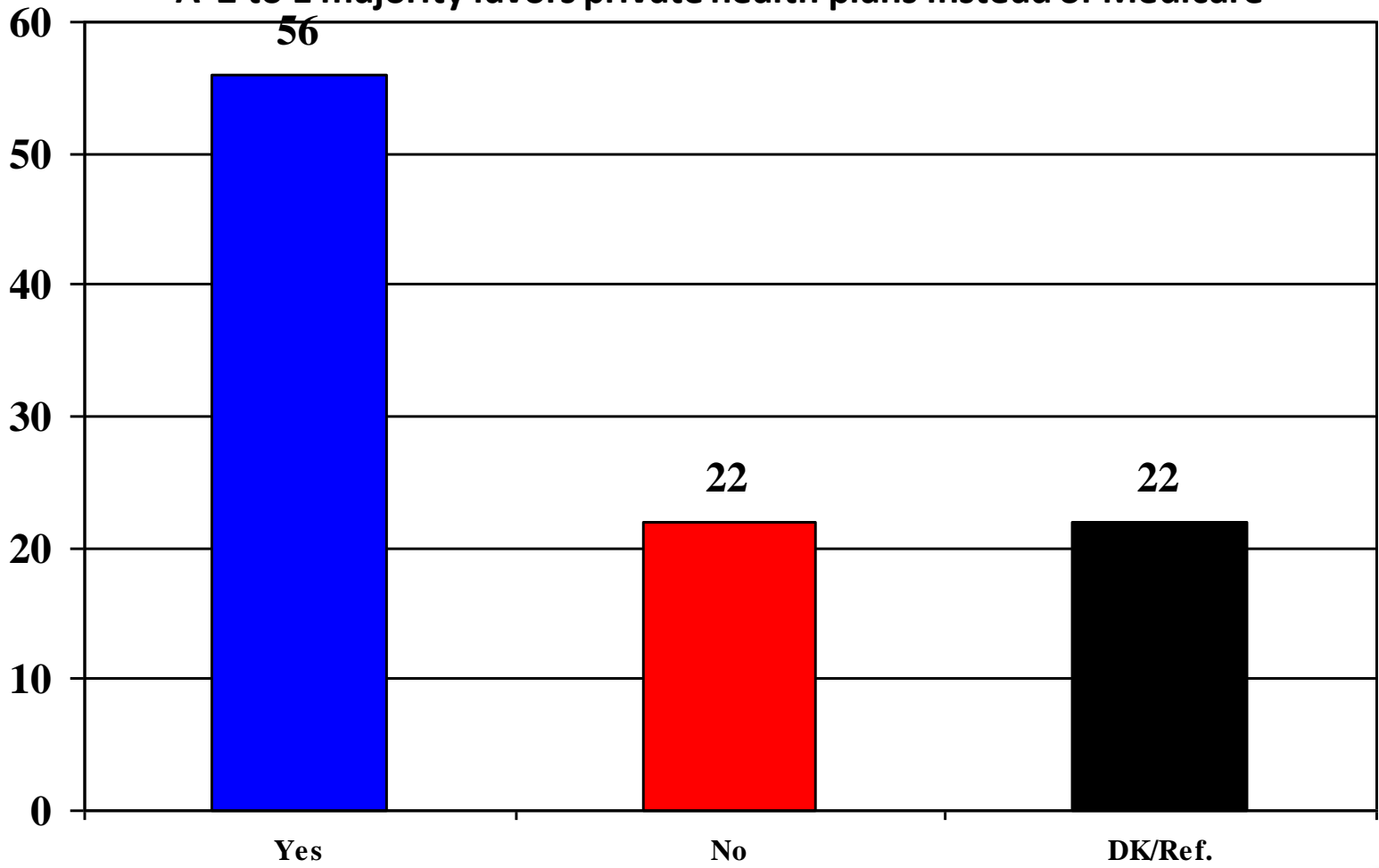

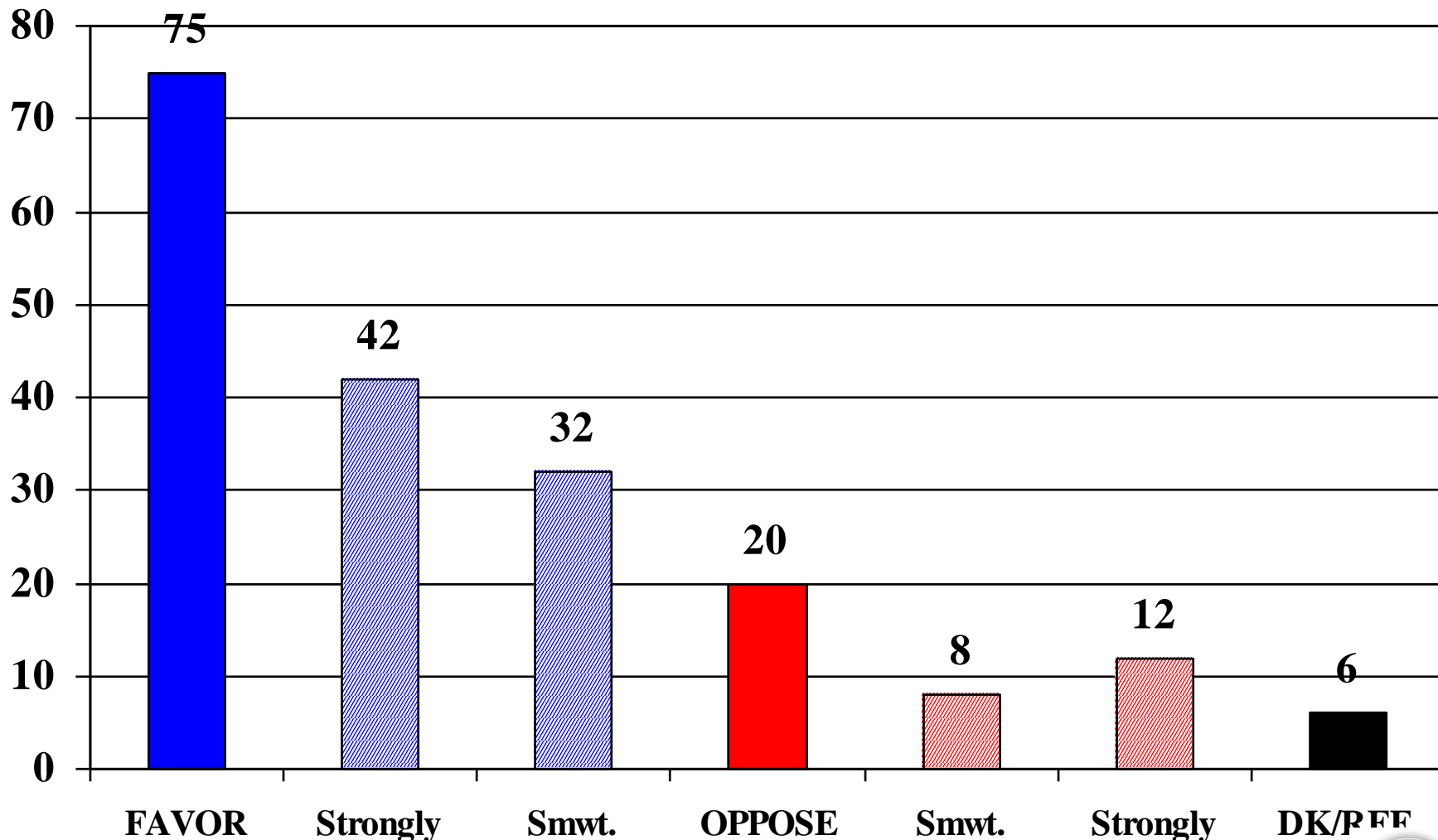

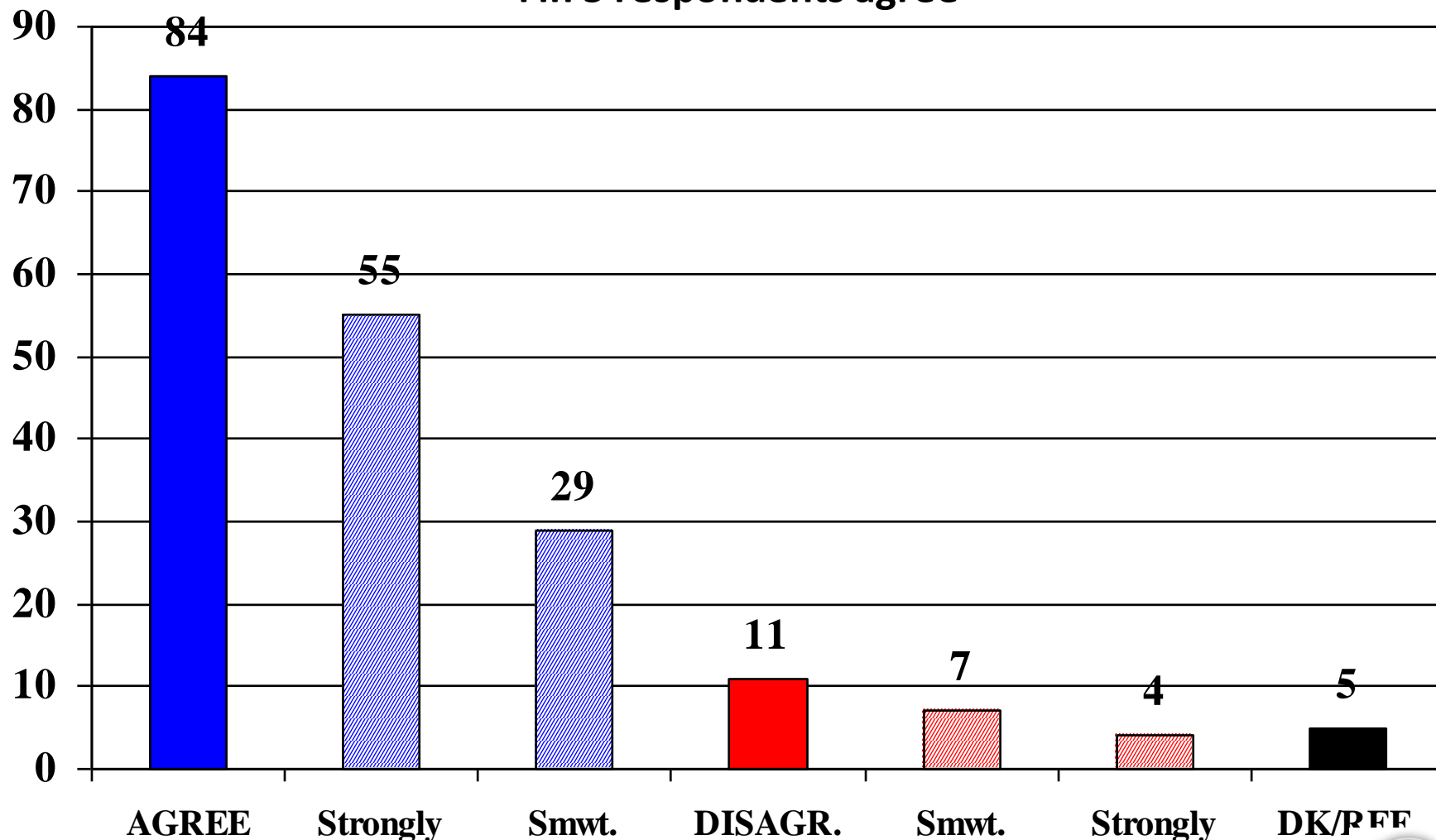

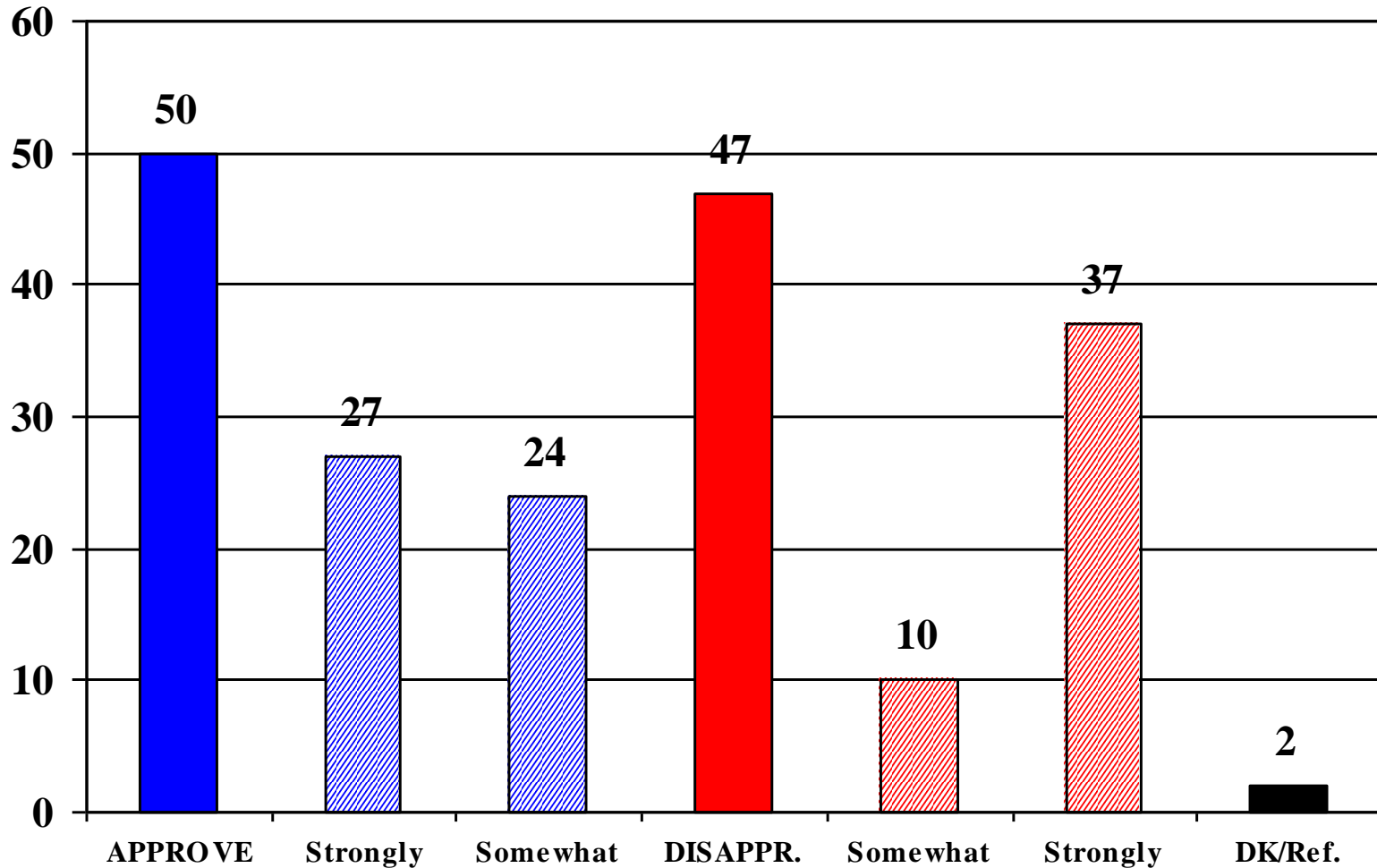

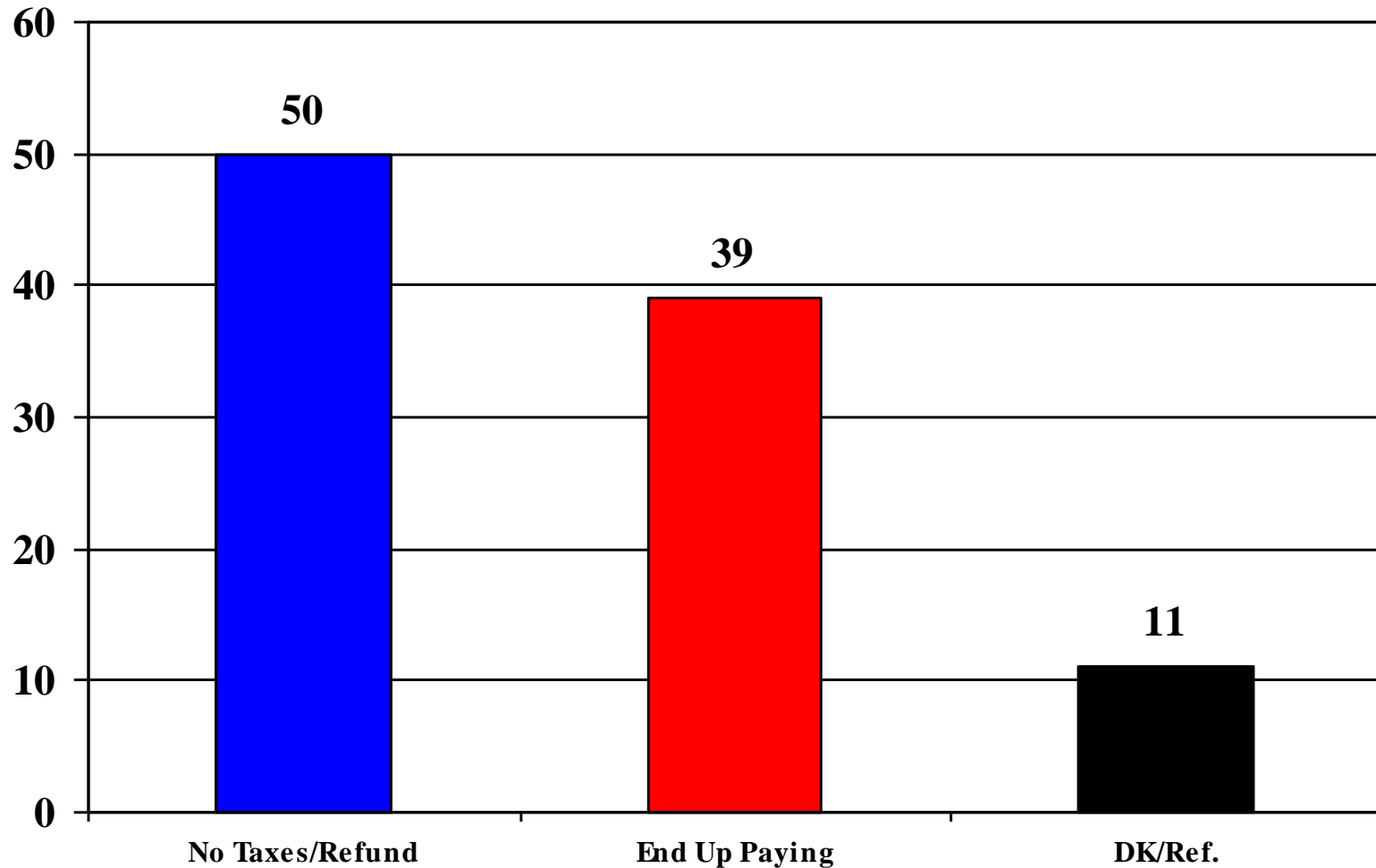
